* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.

* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

THERE WILL BE NO MEASURING OF DOGS AFTER JUDGE'S BRIEFING BEGINS EACH DAY - ALL DOGS WITHOUT A PERMANENT CARD MUST BE MEASURED BEFORE THE JUDGES BRIEFING TO SHOW **THAT DAY - THERE WILL BE NO EXCEPTIONS**

ENTRY ELIGIBILITY: Any trained healthy dog 15 months or older may compete in a CPE Agility Trial. All purebred and mixed-breeds are equally eligible for entry. Bitches in season or any dogs who are blind, lame or aggressive towards people or other animals are not eligible to compete.

JUMP HEIGHTS: Owners are responsible for entering the proper jump height division. All dogs must be measured that do not have a permanent card.

PRIZES & AWARDS: Placement rosettes or ribbons will be awarded for 1st through 4th place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

THIS IS PRIVATE PROPERTY! EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE! ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING OR WARM UP AREA. FLAGGED AREAS ARE OFF LIMITS TO EXHIBITORS.

CLASS LEVEL ENTRIES

The dog must be entered in the same Level for all runs when beginning CPE.

Level 1 is for beginning dogs OR handlers. The standard course does not include the Teeter-Totter or Weave Poles.

Level 2 is for dogs who may have earned at least the beginning title(s) in another organization. Level 3 is for dogs who may have earned AT LEAST the first title or higher in one or more other agility organizations.

Level 4 is for dogs who have earned the respective class legs in Level 3. No dog may begin CPE in Level 4.

Level 5 is for dogs who have earned the respective class legs in Level 4. No dog may begin CPE in Level 5.

Level "C" is for dogs who have earned the respective class legs in Level 5. No dog may begin CPE in Level "C".

Specialist: for dogs who are over 15 months. They MUST jump 8" lower than P-card height, and MUST be entered in Level S classes. The dog may be entered in regular p-card height at the next show.

Any dog 6 years or older, on the day of the trial, may run as a veteran - it is the choice of the handler. Veteran dogs will place with their regular measured height.

Early Veteran: See the CPE website for breed exceptions for early veteran. Effective Jan 1, 2003: any dog measuring under 8" or over 24" may elect to run as an early veteran at any age over 15 months.

OBSTACLES: The following obstacles shall be used. Obstacle specifications shall meet the current CPE obstacle requirements.

* Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. Exhibitors may not use the warm-up area to relieve their dogs.

* Collars are not allowed when a dog is running the course.

* Food, toys and training devices are not allowed on course or in the ring(s).
